

MOLDOVA

Economy

Moldova is predominantly agricultural. Wheat, corn, barley, tobacco, sugar beet, and soybeans are the main crops. Cattle are raised for meat and dairy and beekeeping is widespread. Moldova wine from its central and southern regions is of excellent quality. Moldova is also known for its sunflower seeds, walnuts, apples, and other fruits. The IMF has signed an agreement in 2010 for a development financing programme for approximately \$574m. A Consultative Group for support to Moldova's reform has been set up in Brussels.
