

ROMANIA

Economy

Romania's industries are concentrated in textiles, footwear, light machinery, auto assembly, mining, timber, construction materials, metallurgy, chemicals, food processing, and petroleum refining. Agriculture, though much diminished by disaggregation of landholdings, remains a potential strength with wheat, corn, barley, sugar beet, sunflower seed, potatoes and grapes being grown. Romania has deposits of coal, iron, manganese, chrome, nickel, molybdenum, aluminium, zinc, copper, tin, titanium, vanadium, lead, gold, silver and salt. Environmental factors impinge upon their utilization. Caustic soda, soda ash, sulphuric and hydrochloric acid, and phosphate fertilizers use domestic raw materials. Romania is advanced in IT services and there is progressive adaptation of IT in the service sectors.
